



NOTICE TO MARINERS - HORNSEA ONE UXO Detonation

Hornsea Project One – Notice to Mariners June 2017. Issued 28/06/2017. Update 1

1. INTRODUCTION

Mariners are advised that Hornsea Project One will be detonating the 17 confirmed unexploded ordnance (UXO), at the following locations from 5th July onwards:

All vessels are requested to keep a safe distance of **1500m** around the locations above. All works will be controlled detonations. The investigation for potential UXO is continuing with MV Smit Kamara, MV EDT Protea and Zwerver III and further updates will be issued when further UXOs have been confirmed. The detonation works will be carried out by the **MV Smit Kamara**.

2. SAFETY

Mariners are advised to navigate with caution and keep continued watch on VHF Channel 12 and 16. It is also requested that anybody having knowledge of any potential objects submerged or moored on the seabed, within the vicinity of the confirmed UXO advises the Projects Fishing Industry Liaison Officer of their position and nature. All vessels are requested to keep a safe distance of **1500m** around the locations above.

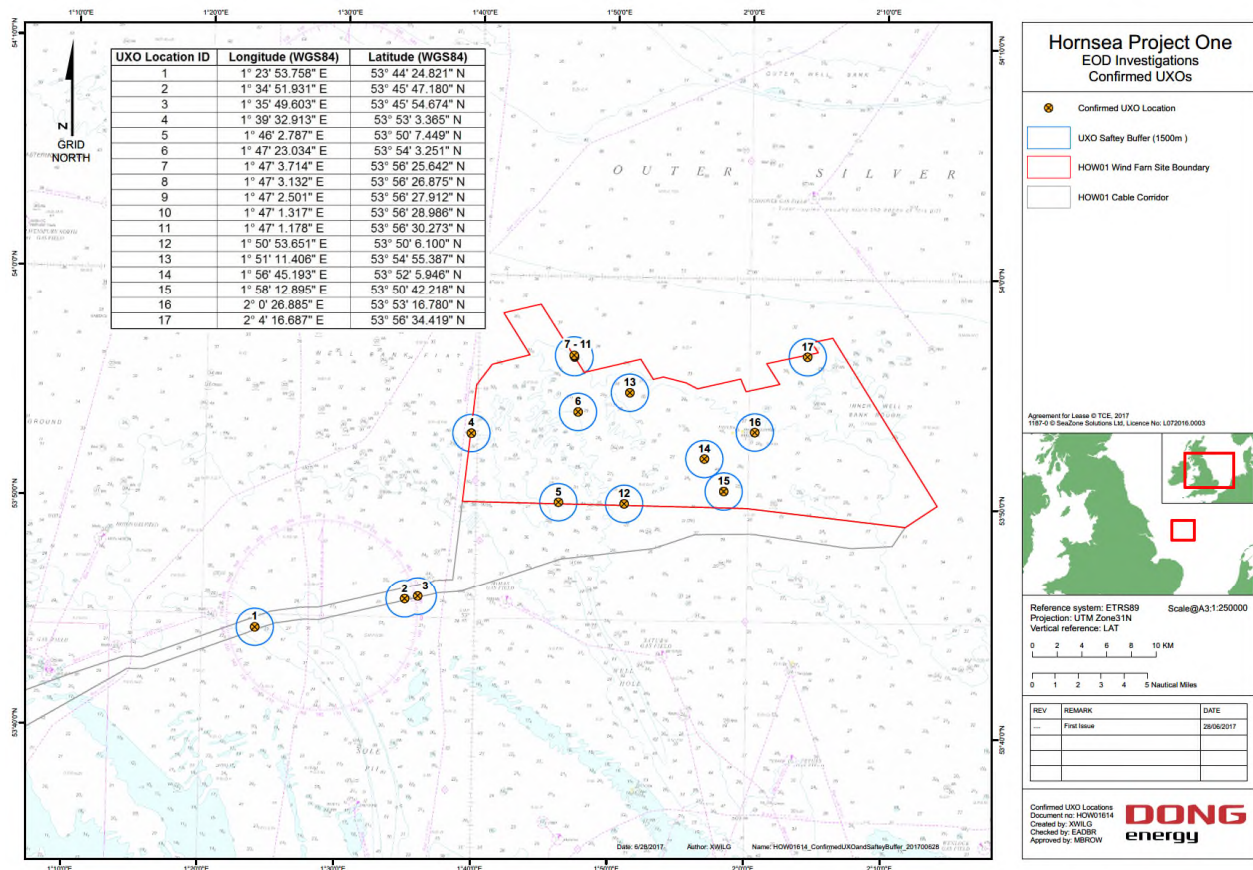
